Maximum 15 (fifteen) tags total in both AIP's - Page tags must **not** carry more than just the topic headings of the page or section. These must be in the English.

Underlining and highlighting are permissible provided these do not include any form of notations.

Apart from CASRs, CAR, CAO, CAAP and VFRG, CASA does not approve use of downloaded air publications such as AIP Book, ERSA, DAPS, etc.

# DO I NEED AN AIP?

It's up to you , lots of people do RPL and PPL with only the VFRG. The AIP has lots of answers to lots of questions as does the VFRG. If you are going on to CPL and ATPL, you will need one anyway and you absolutely should buy the updates package with it.

## INSTRUCTIONS FOR USE

1. Buy a copy of the AIP – follow instructions carefully, so you don't ruin it.
2. Highlight sections shown in accordance with CASA website; Google search: CASA Exams permitted material. Highlighting is allowed, but must not contain notes, just straight normal highlighting. But double check in case CASA rules change.
3. Do not make any notes of any kind in your AIP.
4. Tags Allowed 15 tags in total for the entire AIP ENR and GEN.in English with minimal section titles e.g. Flight Rules, Sep Minima, Fuel. We have made suggestion of common items to tag, that get examined. You must choose 15 in total that suit you.
5. Highlight the sections we show here in your index. Resist the temptation to do more as it makes the important things harder to find. Use a light coloured highlighter at first, so if you decide to colour code later you can go over some items with a slightly darker or different highlighter.
6. WARNING – you will use these for some of your CPL, ATPL and IREX exams. Some of this info will be less relevant by then, so keep that in mind.
7. Do highlighting first and tagging last.
8. Use removable, but reliable high quality tags so you do not destroy your AIP, you want these to stay, but be removable when needed.

**Then use these temporary copies of the AIP which must not be used or shared for any purpose. It shows you what to highlight and that is its only purpose. Then immediately destroy it. It is illegal to keep it and use it or share it for any other purpose.**
